December Board of Review Sessions: NOTICE IS HEREBY GIVEN that the Board of Review will meet under the authority of:

1. MCL 211.53b, purpose of correcting assessment roll figures, such changes being necessary due to clerical error or mutual mistake of fact.
2. MCL 211.7cc, purpose of hearing appeals by owners who owned and occupied a homestead on June 1 & November 1, for current year and the immediately preceding 3 years, if the exemption was not on the tax roll.
3. MCL MCL 211.7b (Disabled Veterans Exemption)
- 4.. MCL 211.7u, purpose of hearing appeals as provided for poverty exemption requests for current year only and limited to those who have not already applied during the current year.
