

SILKSCREENING

Nye Uniform does not silkscreen **any** goods-we use a local Grand Rapids contract silkscreening company.

Small orders of less than 12 pieces are not usually accepted at our contract silk screener. They have committed to do 6 or more pieces of TCFD uniforms for Nye – but no less than 6 under any circumstance. Nye encourages the department to send orders together to minimize the delay. We need to send at least 6 pieces of the same customizing at one time (i.e. 6 tshirts – any mix of long and short sleeve).

Every effort will be made to process all garments with silk-screening as expeditiously as possible, however there may be delays.

SIZING

Nye can furnish sizes needed within the stock parameters of the manufacturers. Many items listed on the bid are not made in sizes requested (i.e. tshirts in tall).

RETURNS

Returns Are Accepted Within 30 Days Of Delivery On Unwashed /Unworn/Unused Goods With Original Packaging And Labels Attached.

Embroidered/Customized Items Are Non-Returnable Unless Defective

Defective Merchandise Still Under Warranty Will Be Repaired Or Replaced As Determined By Nye Uniform.
