The Traverse City Fire Department has 23 uniformed members.**

The bid shall reflect prices for a five-year term, commencing September 8, 2015. If performance is acceptable, the selected vendor will receive a blanket purchase/service order each year of the five-year term. Unacceptable performance may result in cancellation of the blanket purchase / service order or of discontinuance of further orders under the blanket purchase/service order.

Items will be ordered as needed throughout the year. A maximum 30 day delivery time is required on all items.

Descriptions of acceptable uniforms and equipment are attached. All uniforms and equipment bids must be equal to or better than those described in these specifications. The City reserves the right to determine “equal to or better than.” If not bidding the specific brand requested, you must indicate the “equivalent” brand name and model number. Uniform patches will be provided by the Traverse City Fire Department.

The price bid for uniforms must include the costs associated with the attachment of patches, necessary tailoring and adjustments, embroidering and silk screening, on-site measuring, shipping and handling charges.

The Vendor must have a company representative available for personal contact during normal business hours; however, it is not necessary that the company representative reside in Traverse City.

The City of Traverse City is seeking bids for a five-year period for uniforms and equipment for its Fire Department. The Traverse City Fire Department has 23 uniformed members.

Items will be ordered as needed throughout the year. A maximum 30 day delivery time is required on all items.

**BIDS:**

Bidders must complete each item on the attached specification sheets and return all pages to the City. **NO PARTIAL BIDS WILL BE ACCEPTED.** Bids must be submitted by the deadline. Tele-faxed and E-mail bids are not acceptable.

**UNIFORM AND EQUIPMENT DESCRIPTION:**

Descriptions of acceptable uniforms and equipment are attached. **All uniforms and equipment bids shall be equal to or better than those described in these specifications. If not bidding the specific brand requested, you must indicate the “equivalent” brand name and model number.** Tailoring and custom fits must be available. At this time, uniform patches will be furnished by the Traverse City Fire Department. The prices bid for uniforms must include the costs associated with the sewing of these patches onto uniforms by the Vendor (as directed by the Fire Department), and the costs of hemming uniform trousers by the Vendor. **All bid prices must include shipping and handling charges.**

**DELIVERY TIME:**

A maximum 30 day delivery time is required on all items.

**VENDOR’S REPRESENTATIVE:**

The vendor must have a company representative available for personal contact during normal business hours; however, it is not necessary that the company representative reside in Traverse City.

**TERM:**

The bid will reflect prices for a five-year term. If performance is acceptable, the selected vendor will receive a blanket purchase order each year of the five-year term. Unacceptable performance may result in cancellation of the blanket purchase order or of discontinuance of further orders under the blanket purchase order.
