If you are an agent or person appealing for another property owner, **you MUST have a letter of authorization**, signed by the property owner listing each property you have authorization to appeal. The letter of authorization must be presented before appearance to the Board.

**Write-in appeals are to be received by the Assessing Department on or before 5:00 p.m. on Tuesday, March 10, 2026.**
