NOTICE TO CONTRACTORS:

The City of Traverse City will receive sealed bids at the Office of the City Engineer, 2nd Floor, Governmental Center, 400 Boardman Avenue, Traverse City, Michigan, 49684, Until **2:00 p.m. on Thursday, November 2, 2023** for the **Wayne Hill Booster Station Improvements Project**. The work involved in this project consists principally of the following:

1. Replacement of three existing pumps and associated piping and VFDs.
2. Installation of a pressure reducing/sustaining valve.
3. Installation of foot valve and dedicated suction piping from the Wayne Hill Reservoir to Wayne Hill Booster Station.
4. Replacement of magmeter and other electrical improvements.
5. Site restoration for work areas.

Plans and specifications may be examined at the Office of the City Engineer after **October 5, 2023**. Bidder responsible for acknowledgement of all addenda with sealed bid. Members will receive addenda by tracking the project. Non-members will need to log in to check for addenda.

A certified check, bank draft or bid bond without condition to the City of Traverse City in the amount of not less than five percent (5%) of the bid amount shall be submitted as a guarantee of good faith subject to the conditions stipulated in the "Instructions to Bidders". The City of Traverse City reserves the right to accept or reject any or all bids, waive irregularities, and to accept the bids either on an entire or individual basis that is in the best interests of the City of Traverse City. This is not a federal aid project.
