- 66,480 Syd - Seal, Single Chip, Modified
- 1,370 Sft. - Pavt Mrkg, Preformed Thermopl, Decorative Crosswalk, Basket Weave, Brick Red Sand Grout
- 2,284 Ft. – Pavt Mrkg, Waterborne, 24 inch, Special Emphasis Crosswalk
