FACILITIES MANAGER CITY MANAGEMENT

Responsible for overseeing the maintenance, operation, and overall upkeep of all city-owned buildings and facilities, ensuring they are safe, functional, and compliant with regulations by managing budgets, coordinating repairs, maintenance work, and collaborating with other city departments to address facility needs. This role includes coordinating with County Facilities for shared facilities, managing preventative maintenance programs, and ensuring the efficient operation of City infrastructure without direct supervisory responsibilities. Also responsible for managing lease agreements for leased City properties and acting as the point of contact for tenants.

This position is responsible for tracking projects, compiling and analyzing data to support decision-making, and utilizing asset management to make informed decisions about infrastructure investments. Identifying proactive maintenance strategies and ensuring efficient asset utilization can lead to significant cost savings.

The expected hiring range is \$68,358.14 - \$75,789.89 DOE (the full salary range is \$68,358.14 - \$90,014.61).
