The City of Traverse City will receive sealed bids at the Office of the City Engineer, 2<sup>nd</sup> Floor, Governmental Center, 400 Boardman Avenue, Traverse City, Michigan, 49684, Until 2:00 p.m. on December 12, 2025 for the City of Traverse City 120 and 122 West State Street, located at 120 and 122 West State Street.

Please indicate in the subject line of your email that you are submitting a "Sealed Bid" together with the project description "City of Traverse City 120 and 122 West State Street" and submit your emailed bid to <a href="mailed-bid">tcmanage@traversecitymi.gov</a> before 2:00 P.M on December 12, 2025.

The work involved in this project consists principally of the following:

Universal Waste Disposal, Asbestos Abatement, and Building and Infrastructure Demolition

A certified check, bank draft or bid bond without condition to the City of Traverse City in the amount of not less than five percent (5%) of the bid amount shall be submitted as a guarantee of good faith subject to the conditions stipulated in the "Instructions to Bidders". The City of Traverse City reserves the right to accept or reject any or all bids, waive irregularities, and to accept the bids either on an entire or individual basis that is in the best interests of the City of Traverse City.
